Líder sul-africana é acusada de corrupção

Procuradores sul-africanos disseram à segunda-feira que eles pretendem acusar a oradora do Parlamento de corrupção, alegando que ela recebeu USR\$ 135.000 e um peruca onabet da bonus propinas ao longo de um período de três anos enquanto era ministra da defesa.

A porta-voz do Parlamento, Nosiviwe Mapisa-Nqakula, ainda não foi presa ou acusada. Os procuradores falaram onabet da bonus uma audiência onabet da bonus tribunal sobre as alegações de que as autoridades não informaram adequadamente a ela das alegações ou seguiram o procedimento adequado.

Espera-se que o juiz decida sobre um impedimento de prisão na segundafeira à tarde.
